
In July 2004 New Bylaws Were Approved.

By February 2005, using the ambiguity and loopholes in the 2004 Bylaws the Board pushed through a proposal to Approve a 99 year lease of 8 acres of land on the very front of the property at TRF Mount Ecclesia for the purpose of building 140 Condominiums for income from their sale or rent.

Oceanside City rules require public information meetings to obtain neighborhood's positive feedback on the project before City approval is possible.


Here is what the plan was:


Picture of the

Here is a map showing the location of the Land selected for Condos (Purple Lines) on West and East portion of the Property using 8 acres out the 26 usable acres on prime frontage land.



The plan was to build the 139 condos. The land was to be leased from TRF for 99 years (beyond anyone life expectancy, therefore leaving future responsibilities to next generations.) California Condos are made of wood to be able to withstand earthquakes and after 50 years they require upgrade. But what happens after 99 years? No funding or financial provision was made to help TRF pay for the clean up the old termites condos that need to be either upgraded or bulldozed after 99 years!

This is a \$90 Million project. If the building cost was 1/2 or about \$45 Million, why was the Board Member/Developer planning to give TRF only \$9 Million (or 12 condos worth!) Also certain members of the Board were to get free condos for themselves and their families. The question is: Was TRF really going to benefit from this venture, obviously many others were going to benefit?

No one is supposed to profit from any of TRF assets as they belong to humanity? Then how would that work in relation to TRF 's non profit status? And wouldn't the business of selling condos jeopardize its Tax Exempt status?

But after three public neighborhood meetings, some involving unethical tactics, the project was rejected by the neighborhood and the City. Then the whole plan unravelled. "Somebody was watching from above" but it was a close call!

EXAMPLE #2

Then later in 2005 another idea was floated to bring more money by leasing/selling the 13 acres of slopes to developers who are required by California Law to reserve 10% of space for the preservation of native plants when they apply to build any construction project, and such reserved conservation space can be selected anywhere land can be leased or purchased by the developer.

The 13 acres of our land slopes were to bring in a mere \$215,000 and then we would lose dominion over the land and could no longer interact with it. If we planted grass above the slopes around the Temple or the cottages or the apartments and some fertilizer was to drip down the slopes injuring native plants we would be open for lawsuits.

Then if the owners of the native preserves area were trying to bring revenues by contracting with various schools and other youth organizations to visit for education purposes, they would use our land, parking lots, and amenities for the buses and school children to access the areas, coming with their skate boards, radios, sandwich and coke cans that invariably get thrown away and all that trash quickly interfere with our clean, quiet and peaceful spiritual center.

EXAMPLE #3

Sale of Trees and Rare Books

Then in early 2006 the administration with the blessings of the International Board decided to sell 4 palm trees located on the smaller roads adjacent to Ecclesia Drive.

They also sold some rare books from our TRF library in the Guest House to other libraries and on eBay, Craigslist, and other such selling sites. Such losses cannot be retrieved.

This gave others the idea about selling less visible assets like old documents and other precious books as well as the much visible and expensive Phoenix Canary Palm Trees planted on the property some 96+ years ago by Mr. Heindel and that were worth a lot of money.

Example #4

The Exceptional Employment Agreement

Anticipating potential problems in relation to her self-appointment as President of TRF and the subsequently planned sale of the Palm Trees, and possibly the land, the President soon to be placed on administrative-leave-without-pay wrote for herself a never-heard-of-before "Exceptional Employment Agreement" whereby she was giving herself all sorts of benefits, securing her position as president for 5 years in violation of the bylaws, and giving herself full power to control every department, especially the finances at Headquarters, with free housing in the largest house at Mount Ecclesia. Even though the finances were very low and everyone else was on limited part-time pay, she was shamelessly awarding herself full time pay with all benefits, like sick pay, vacation pay, bonuses, retirement benefits, Health Insurance benefits, things that no other employee has ever received before...

She claimed the Agreement had been approved by the International Board and signed by the Chairman since, as President, she had a conflict of interest if she signed her own contract. But it was revealed that the Board never met to discuss such a contract, neither were any other Trustee aware of its existence, only the Chairman of the International Board from Spain who signed it during a fictitious Board meeting between the both of them. When questioned, the Chairman claimed he did not keep a copy of the contract (!), he just signed it and mailed it back !!! Fishy, very fishy indeed. !

On March 9, 2007 the newly self-appointed President came to take residence at # 3 Canyon Lane the largest cottage next to the six-pled at Mount Ecclesia. She expelled the previous President and accused her of stealing documents, she also barred access to all the volunteers and established her reign of terror by threatened all employees of explosion if they were to speak or say anything to any one outside the Grounds. Then she proceeded with her plan to rape the Fellowship by selling 64 palm trees on the premises that they were sick and contagious , a claim denied by the County of San Diego inspection the year prior. The trees replacement is valued at between \$1,280,000 and \$4,800,000 but no official agreement was found in the records and the Fellowship never saw a dime of it. Witnesses saw her getting a check from the landscape Forman. When asked about any of it she would not answer any questions, and slam the door.

Considerations on Past President's performance and influence on Mt Ecclesia, Before disappearing after being placed on Administrative leave.

1. By skillfully manipulating information about work at Mt Ecclesia to the International Board of Trustees, Board Chairperson A.P. in 2007 has voted herself all the power, positions, privileges and pay, she presently enjoys as reflected in the minutes of the Board.
2. She said she has drawn a special contract and asked the Board to approve it when she was Chairperson, but there are no minutes to reflect such a vote and we do not know who signed it since, to this day, no one has seen it and she absolutely refuse to produce it. The alleged contract would secure her position as President for 5 years! Such would be a first in the Fellowship's history, in violation of the terms of Fellowship bylaws ruling that the Board appoints its officers (the President included) on a yearly basis.
3. She has abused her privilege as Esoteric Secretary by dropping members from the active list without customary procedures, designated members as inactive or manipulating the Board of Trustees to classify certain long standing members as "members not in good standing" for political reasons, to prevent them from holding office, attending or participating in services, correcting lessons, voting or otherwise participating, in the affairs of the Fellowship.
4. As President and Chief Executive Officer of the organization, she has been negligent in not seeing that the Board meetings take place in an open fashion and that minutes of all Board meetings be posted promptly (no minutes after May 2007) leaving the Fellowship in default of the law ruling Non Profit Organizations that requires that Board meeting be open to members and minutes be posted and accessible by member for their review in a timely fashion.
5. She has lied and misrepresented facts to the Board members about the state of affairs at Mt Ecclesia and is the worst steward the Fellowship has ever had. As President she has not done anything to address the major problems that plague the Fellowship, such as extremely low book sales, low rate of membership applications, increasing number of out of prints books, very low donation rate, absence of program for spreading the Teachings, a total absence of activities... to name a few. She has closed the prisoner's correspondence course program and has vastly reduced the correction of the lessons in the US. She has voluntarily neglected the welfare of the property at Headquarters and abandoned housing assets by keeping them empty as they deteriorate for lack of use when members were offering to rent them and fix and attend to them for free or on a volunteer basis. It looks like she wants to close the place with intention to sell.
6. She has made promises of actions she has never delivered on, regarding:
 - a.) Making a plan for the future of the organization,
 - b.) Reviewing application from locals member applicants to come and volunteer.
 - c.) Creating a new website for Board minutes and other corporate news for member review, and material posted on a timely basis,

7. A.P. asks for volunteers and yet she really does not want any as witnessed by the eviction of:
 - a.) Most local probationers who were volunteering and helping for free when she arrived in March 2007,
 - b.) K. and E. Ray, who offered to work for nothing and pay \$300/mo rent. K. also offered \$50 towards the water bill. The Fellowship lost \$3,000 in rent from the Rays and the Fellowship incurred \$3,000 in legal fees to evict them and others.
 - c.) Helen Schroeder who has worked faithfully for the fellowship for 39 years and was battling Cancer and died very shortly afterwards being evicted, and as a result of emotional shock of the eviction.
 - d.) M. Colman a black woman who left everything after being invited to come to work at MT Ecclesia by the prior President, was denied any opportunity to do so by A.P. who regularly harassed and threatened her with eviction. The stress caused her a mini-stroke.
8. In 2006 the cafeteria funds, that were held in a separate account (!) under the care of A. P. with the \$3000 it contained disappeared mysteriously when A.P. left the grounds for New York. There's a cloud of suspicion as to whom stole the money she was separately and jealously guarding? She claims she had it in the piano (?) and someone stole it! (wink!)
9. She decided to purge the Probationer Membership List without any supervision while an election process was going on, which is highly irregular and the resulting totals suspiciously happened to magically match the 34% votes required to make a quorum for the elections to the Board. But none of it can be checked as she is not providing an official membership count in her annual reports for two years in a row! No one's watching the chicken coop!
10. She secretly handled the Election results with a committee she appointed herself and whose members were not all present at the counting. The Board added committee members but they were not welcome nor invited to the counting.
11. In her Annual Report for the second year in a row, by her own declared admission and personal decision A.P. has failed to disclose customary Fellowship statistics such as detailed membership counts by regions, number of lessons corrected by department, number of new membership application, number of new students and probationers and other vital statistic a non profit organization is required by Law to provide its members and the general public for review, failings that may jeopardize the Non Profit status of the organization.
12. She refused to answer any questions nor be made accountable for the sale of 64 palm trees planted by Max Heindel in 1912, with an estimated replacement value between \$1,280,000 and 4,800,00. She removed assets of the Grounds without proper written permission from the Board and left no evidence of any contract with Junglescape as all transactions were made under the table. The International Board did not know so many would be sold. No money ever came to the Fellowship treasury, as she ran with an unknown amount.

EXAMPLE # 5

In the spring of 2007 the self-appointed President of TRF had the International Board believe that the Palm Trees were sick, infected with Fusilium bacteria and were dangerously contagious to other palms trees. She claimed 30 sick trees needed to be removed to stop the damage to the other palm trees.

In fact only 3 trees were dead and not from the Fusilium bacteria, but two due to malnourishment and the one due to a strike of thunder and lightning.

In the end 64 Majestic Phoenix Canary Palm Trees planted by Mr. Heindel, 95 years earlier, were removed form Mount Ecclesia and no one but the President collected the money and the Fellowship did not get a dime!

Each of these trees were worth between \$20,000 and \$75,000 a piece!

Do the math: The Fellowship lost somewhere between:

$$64 \times \$20,000 = \$1,280,000.00 \text{ or}$$

$$64 \times \$75,000 = \$4,800,000.00$$

and the President vanished without a trace leaving no address behind, the day after she was placed on administrative leave by the International Board, for not answering any questions about the trees or any arrangements thereof.

These 64 Canary Palm Trees were valued at tens of thousands of dollars each. They had been planted by Max Heindel in 1912, some 95 years earlier yet the grounds were raped and destroyed and the Fellowship received nothing.

MOUNT ECCLESIA BEFORE AND AFTER

- * April/May 2007 Trees removed and sold by the President, who was controlling the International Board.
- * The International Board would not listen to anyone on, or outside Headquarters, only to the President, who was secretly pushing her own selfish and greedy agenda. Mount Ecclesia had no legal recourse. We all sat and watched. Nothing legal could be done.
- * 2008 Newly Elected Chairman of the Board, contacted TRF's lawyer. and was told: There was nothing we could legally do as a California Corporation, against the International Board members living outside the US Jurisdiction. (Because Board members were not legal Citizens of USA, so, were not liable - nor could be held liable- for any decisions made to this Calif. 501 (c) 3 non-profit Corporation. He said, "we might be spiritual, but legally, we are not business savvy or wise because we are *"a business, with a spiritual purpose, only protected by California and US Law"*).
- * The President was put on administrative leave, and was to remain in her home at Mt. Ecclesia during the investigation. But the next day she was gone, she left in the dark of night, taking money, corporate documents, TRF records and TRF assets with her. There was nothing that could be done, though we went to the Police, to the City and even found those who would testify that moneys were paid before any one tree was removed. We could do nothing except pick up the pieces and go on.
- * As the Trustees were not legal Citizens, US Statutes and California Law had no authority, no jurisdiction outside the US and Police could do nothing.
- * That was when the New Chairman, was contacted by probationers who wanted to start a petition to change the the 2004 Bylaws and this procedure began in 2010.

One nursery man trimming the trees for removal, showed us from the one dead tree that was struck by lightning, that by counting the rings, it showed us these trees were close to 100 years old and were well cared for the first 40-50 years.



If half the trees (30) were said to be sick and to be removed to prevent infection of the others trees then why were all the trees trimmed with the traditional "pineapple cut" with their "trunks shaven" as if to be sold?
Because they were going to be sold as, they were not sick! That was the plan from the beginning.



EXAMPLE # 5

The President did not answer any questions about the palm trees, the contract and the money, asked by the Board and was placed on-administrative-leave without pay and was ordered to stay around during the investigation. She disappeared without leaving an address the day after she was placed on Administrative leave and took some corporate files and corporate assets and continued to interfere and manipulate the Trustees from behind the scene. Effort to prosecute were useless since the majority of the Board who made decisions was outside the US Jurisdiction.

We write to you requesting help in recovering 64+ Canary Palm Trees, which has been stolen from the grounds, an historical landmark in Oceanside, at The Rosicrucian Fellowship at 2222 Mission Avenue. We have pictures showing that the company that removed them is JungleScape, and a trucking company Langmaack & Sons Ontario, Ca helped haul the palms away (see pictures) To date absolutely no money has been received for them. As concerned citizens and members of The Rosicrucian Fellowship, a 501 C-3 organization, we are requesting your help in this matter.

A Brief History of events:

Last year, JungleScape started marking, grooming and removing the tall stately Canary Palms located on the Fellowship Grounds that were planted in 1912. Then President, Alexandra Porter told everyone the trees were diseased and had to be removed. [At that time, the trees were examined by at least two tree specialists and no disease was found.] However, the trees were removed. We have gone to the Police Dept. on Mission Avenue, twice, to make a report that these trees valued anywhere from \$20,000 each to \$75,000 each had been stolen, only to be turned away, because we were not board members. Since then, we have tried unsuccessfully to contact JungleScape and Mr. Larry Rocker, (then General Manager), to see if they had a contract to remove these trees and proof that all these trees were diseased, or if they indeed had a contract to buy and remove any trees, or had given anyone at RCF money for any of the trees removed.

Then President of the organization President, Alexandra Porter has been put on administrative leave as the Fellowship starts its own investigation to the misuse of funds and handling of general business upon the grounds. (The Board Members of this organization during 2007 through April 2008 were located around the world, not in the United states. Ms Porter had free reign to do what she wanted and only report back to the board what she chose. She had closed the grounds to members, forbidding them to hold classes on the grounds or make inquiries of the trees. She also threatened the few employees remaining that they would lose their job and home if they talked with anyone about the trees.)

After the general election, this past July 2008, a new Board of directors, with some Board Members in the United States, took office and has started an in house investigation into Ms. Porters actions to provide members with some answers. To date, the fellowship has not received any money from JungleScape for the trees removed. JungleScape has not responded to requests to provide contracts or cancelled checks for said trees. Of the 81 Tall Canary Palm Trees on the grounds, only 10 remain. These ten are groomed and ready to go except for the fact that Ms. Porter has now been placed on administrative leave and forbidden to handle any fellowship business until further notice.

The removal of these beautiful trees now reduces the value of these grounds which is in direct violation to a court decision stipulating that all assets of RCF were not to be removed from the grounds for any reason (Court case, January 5, 2007 (No GIN047003, by Marie Clerk.) Ms Porter has refused to give anyone information, (like a contract between JungleScape and TRF or herself.) She continues to declare the trees were all diseased and all the trees were removed, so the few good trees would pay for removing the diseased trees. (Which makes no sense.. either all were diseased or none were diseased and If "not all" how many were supposed to be diseased?) What is very strange is the fact that ALL the trees removed, (as you can see in the pictures), were carefully groomed, removed and carried away on trucks, not cut and ground up on the grounds as were the two trees that had been struck by lightening several years before.[Members have reported that a few of the trees that were removed from our grounds can be seen at the JungleScape yard.]

Attached pictures of the grounds (before, during, and after removal) were taken prior to April 30, date, (which is prior the president says the Board of Directors gave her permission to remove the trees.) (We also have a video of the trees and the grounds from which these few pictures came from.)

Ms. Sanchez and members of the City of Oceanside. We do not know where to turn, so are seeking help from the City Officials to request the Police get involved in finding out if indeed JungleScape together with Ms. Alexandra Porter stole these 70+ trees from these grounds, that could be valued up from 1,280,000 to \$4.800,000, or more. If so, this represents possible fraud or grand theft.

We have tried to contact Jungle Scape who removed the trees, but no one will return our call or talk with us. We have tried to get more information from President, A.P. who requested the removal (see attached), and who fired the accountant and has failed to pay taxes now due since May 2007.

We have gone to the Police on Mission Avenue twice and both times this matter has been dismissed. If someone steals a tree valued at anywhere between \$1,280,000 and \$4,800,000 dollars and no one has received the money, that seems to indicate a theft... either by the company removing the trees, or the President acting on behalf of a Board of Trustees, located totally outside of the United States of America.

As this is a membership organization, and we have been members for over 20 years, we feel that this felony must be resolved. The Fellowship has to go to the IRS at this time and has nothing to show for the trees removed, and the decrease in land value because of it.

We therefore request that this matter be looked into so that we can legally provide the IRS with information regarding this problem.

EXAMPLE #6

The President-on-administrative-leave did not give up the fight until she got her desires met. She use one of her Board appointee's email and impersonated that woman to communicate with International Board Members in foreign countries, behind the scene, and without Headquarters knowing. She told them her sob story that, she had been removed unjustly as President when she was such an upright and honest person (!) She told that the "Anglos" were persecuting her and that she should be reinstated as President and awarded \$26,000 in back pay and allowed to return to work at Mount Ecclesia to finish her term! (to secretly sell off Mount Ecclesia since she got away with a selling off 64 Palm trees and pocketing the money!) and a majority of the International Board bought the argument and was ready to vote for it. Fortunately the Skype connection broke and when the connection was reestablished a quorum could not be formed, so the meeting was adjourned by the chairman from Ghana. Thank God a miracle happened!

Obviously there is far more to this incredible story that none of you seem to be familiar with, but it should give the Board and the Members a flavor of the risks left open by the legal loopholes planted in the 2004 by a few who had a hidden agenda. Someone argues: "the 2004 Bylaws are legal so why change them?"

It is Important that we make the thoughtful corrections that were thoroughly researched and worked on during the past 4 years. The Board voted to accept these new bylaws be presented to the members for their approval and put into place before it is too late.

Landscape companies are still asking to buy the remaining trees and Real Estate Agents and Developers are knocking at our doors to develop our property!

Both Landscape companies are still hounding TRF to sell them the remaining palm trees.


